# What is PFAS?

Per- and Polyfluoroalkyl Substances, or PFAS, are a group of manmade chemicals used for a wide variety of residential, commercial and industrial purposes including: nonstick cookware, stainresistant fabric and carpet, some food packaging and fire fighting foam.

PFOS and PFOA are components of legacy Aqueous Film Forming Foam (AFFF) that the Air Force began using in the 1970s as a firefighting agent to extinguish petroleum fires. AFFF was used extensively at Fairchild AFB from the 1970s until 2016 to fight petroleum fires.

# **Remediation Strategies**

For PFOS/PFOA contaminated wells located within the sampling area that have been sampled and tested above the DoD Policy of 70 ppt, the Air Force is offering two options:


- 1. Connection to a municipal water supply
- 2. Installation of a Granular Activated Carbon (GAC) filtration system Residential treatment systems are designed with three GAC filtration tanks for redundancy and increased safety. GAC removes contaminants, including PFAS compounds, from drinking water through adsorption. The systems also include particulate filters to remove any sediment/sand from the well, and an ultraviolet (UV) disinfection system for additional removal of bacteria and microorganisms. Sampling and routine maintenance of treatment systems is conducted quarterly. A 24-hour hotline is available for emergency repairs and response. The hotline number is (971) 770-1145.

#### Sampling Summary (as of December 2023)

- AF sampled 427 private drinking water wells.
- Detected above 70 ppt: 107 private wells.
- Detected above 70 ppt: 2 out of 4 municipal wells.

#### **Treatment Systems and Status**


- 90 residential systems in place/installed.
- 4 homes connected to municipal water supply
- 5 pending GAC filtration systems
- 6 locations sampled and above 70 ppt (no longer used for drinking water)
- 2 GAC filtration systems removed




# Legend
